NorCal Bulldog Rescue Report: Difficult Decisions

ummer is usually a challenging time for rescue. Families often choose July/August as a time to relocate prior to the start of the next school year. We have seen several families that are "downsizing" and moving to locations where they are unable to take their pets. To date, NorCal Rescue has taken in 57 bulldogs so far this year with 3 more awaiting a foster spot. The financial support that the membership of BCNC provides to our rescue effort makes it possible to help some of these dogs that less well funded organizations would have declined, especially the "seniors." This financial support, coupled with the generous vet assistance from Blue Ravine Animal Hospital in Folsom and Grove Way Vet Hospital in Castro Valley, makes it possible to help dogs such as the following three oldsters.

Otis: A sweet 8 year old with heartworm disease. He is currently being fostered by Jennifer and Jay Joseph. Thanks to Dr. Sweet, Patti Rungo and the staff at Blue Ravine for their help with this boy. Additional thanks to Erica Peters for her help with transport. He has now completed his heartworm treatment and is ready for placement. He is described by those who have spent time with him as one of the sweetest boys we have had in this year.

Lulu: A senior that was adopted by a family off craigslist after being told by her original owner that he was "going to shoot her if they didn't take her." They surrendered her to rescue after finding that she needed extensive medical care that they could not afford. Her estimated age is 8. She is a sweet, gentle girl who is very good with small children and is

making an amazing recovery after extensive surgery to remove 8 severely infected teeth, multiple mammary tumors, and to be spayed. With appropriate eye meds her vision has improved dramatically. Thanks to Dr. Hackler at Grove Way Vet in Castro Valley. She presents some special challenges for placement since most of our adopters will always prefer a younger dog. She is currently being fostered by Maggie and Scott Waldon in Benicia who report that Lulu has incorporated well into their pack of pets that includes multiple dogs and cats. We hope a permanent home will surface for Lulu but in the meantime she is living the good life. Due to her arthritic shoulder it is difficult for her to keep up with the other dogs on regular walks so she gets pushed in a stroller by her foster dad. He reports that if he does not go fast enough to suit Lulu, she expresses her displeasure with the slow pace by barking.

Jose: Age unknown but estimated to be 8 or over. He was found wandering on a busy street in south San Jose and no one ever came to claim him.

He was functionally blind from neglected dry eye when he came into rescue. Flea infested with resulting skin issues, he has now been neutered, his dental work completed, is on much needed eye meds and his vision has returned. Erica Larson in SF, who is a BCNC member, is fostering him. We are awaiting a permanent home for Jose as well. He is a sweet, quiet gentle boy who asks only for a warm place in the sun to watch the world go by. until they eventually find their way into rescue. They ask for far less than younger dogs, they have been around the block and have seen the good and the bad of life. They are often the sweetest dogs we get in rescue and most rescuers often lament that if they could, they would build a facility and take in all the old and abandoned.

Sadly two dogs with spina bifida were euthanized after veterinary evaluation. One was only 4 months of age, the other only one year of age. These situations are very difficult for those of us who rescue. We often see the results of these inappropriate placements of incontinent puppies by breeders to avoid the difficult decision of euthanizing the puppy at a young age. ou've undoubtedly seen them in your mailbox. Cute little reminder cards from your vet that it's time for Beauregard's annual vaccinations. But after looking a bit closer at the risks and benefits of these vaccines, you might want to pause before making that appointment.

Could these vaccines not only be unnecessary, but actually harmful to your pet's health? Absolutely.

We overvaccinate our children -- but at least we eventually stop after puberty. But with our pets, we continue vaccine boosters until they are well into their senior years.

As adults, we don't assault ourselves with annual boosters, and we certainly wouldn't do this to our elderly family members. So why do we inflict this upon our pets, regardless of their immune status or age, when common sense would tell us those vaccines should last longer than a year?

Additionally, there are no adjustments in dose for size or age of your animal. Your five-pound Miniature Pinscher receives the same size vaccine as your 150-pound Rottweiler. Your 10-pound housecat gets the same amount as a 400-pound lion.

All of these vaccines are overwhelming your pet's immune system. Vaccine reactions are at an all-time high.

A study of more than 2,000 cats and dogs in the United Kingdom by Canine Health Concern showed a 1 in 10 risk of adverse reactions from vaccines. This contradicts what the vaccine manufacturers report for rates of adverse reactions, which is "less than 15 adverse reactions in 100,000 animals vaccinated" (0.015 percent).

Additionally, adverse reactions of small breeds are 10 times higher than large breeds, suggesting standard vaccine doses are too high for smaller animals.

A few bold veterinarians have paved the way for ending overvaccination, but the research is sparse and the opposition is great, just as with the human vaccine industry -- and for similar reasons.

In this article I will be addressing three main points:

1. There is no scientific evidence that annual vaccines are necessary, and in fact once animals achieve immunity from their initial vaccines, they appear to have immunity that lasts for many years, *and often for life*, without boosters.

2. There is growing alarm that overvaccination appears to be causing a multitude of serious medical problems, particularly with the immune system, including allergies, seizures, anemia and cancer.

3. Vaccines are a very profitable part of veterinary care -- in fact, some vet practices are built around them. Long-term studies of animal immunity would require a substantial outlay of money -- the kind of money that only the drug companies have, and *Big Pharma is much more interested in selling more vaccines than challenging the need for them.*

How Current Vaccine Schedules Were Determined

The current recommendation from many veterinarians is for dogs is to receive rabies, parvovirus, distemper, adenovirus, parainfluenza, leptospirosis, coronavirus, hepatitis, lyme (borelia), and annually, bortadella (kennel cough) sometimes being recommended every 6 months.

Cats are advised to have rabies, feline leukemia (FeLV), distemper (panluekopenia), rhinotracheitis, and calcivirus annually-and depending on risk, chlamydia, feline infectious peritonitis (FIP), and ringworm can be added.

Many vets advise both puppies and kittens get their "core vaccines" at ages 6 weeks, 8 weeks, 10 weeks, 12 weeks, 14 weeks, and 16 weeks. Then, they get boosters at one year, and annually thereafter.

All of these shots add up to a tremendous vaccine load over your pet's lifetime!

How did these recommendations for annual vaccines come about?

One of the veterinary pioneers, Dr. W. Jean Dodds, president of the nonprofit animal version of the Red Cross called Hemopet, reported that the recommendations for annual vaccines were just that -- recommendations. They were not based on any scientific evidence.

The recommendations for annual vaccination were put forth jointly by the United States Department of Agriculture and the drug companies, more than twenty years ago. And veterinary medicine has continued to do it that way because, well, that's the way it's always been done.

And it's a good deal for them financially. So far, protests to annual vaccines have been mild.

Now the USDA puts the annual vaccination recommendation right on the product label.

Veterinary Vaccines are Big Money for Many Vets -- and Even Bigger Money for Big Pharma

Without some driving force for change, there is no motivation for the industry to change the most lucrative part of its practice.

Many vets cling to annual vaccine schedules because of economic dependence more than maintaining a "cautious" standard of care. This is particularly true for the typical small vet practices (1-3 people, non-specialty, non-emergency practices).

Consider this ...

One dose of rabies vaccine costs the vet about 61 cents. The client is typically charged between \$15 and \$38, plus a \$35 office visit. The markup on the vaccine alone is 2,400 percent to 6,200 percent -- a markup equivalent to charging \$217 for a loaf of bread.

According to one estimate, removing the one-year rabies vaccination and consequential office visit for dogs alone would decrease the average small vet's income from \$87,000 to \$25,000 and this doesn't include cats or other vaccinations.

According to James Schwartz, author of Trust Me, I'm Not a Veterinarian, 63 percent of canine and 70 percent of feline vet office visits are for vaccinations.

Clearly, radically changing the vaccine schedule for dogs and cats would result in a huge economic loss for any veterinary practice that is built around shots.

And chances are the vaccines you are paying so much for are creating even more income for vets, because the adverse reactions and other medical issues caused by the vaccines keep Fluffy coming back often!

The profits for vets pale in comparison to the profits being enjoyed by vaccine manufacturers. Veterinary vaccine sales amounted to more than \$3.2 million in 2004 and have risen 7 percent per year since 2000. This figure is projected to exceed \$4 billion in 2009.

Six companies account for more than 70 percent of world veterinary vaccine sales. The market leader is Intervet, with sales of almost \$600 million in 2004. That's a whole lot of 61-cent vaccines.

The United States has by far the largest share of the national market with revenues of \$935 million, and Japan comes in second with \$236 million.

Medical Risks Outweigh Benefits

In 1991, an unfortunate observation led many vets to begin rethinking the vaccine protocol.

A lab at the University of Pennsylvania noted a connection between a troubling increase in sarcomas (a type of cancerous tumor) and vaccinations in cats. Mandatory annual rabies vaccinations were leading to an inflammatory reaction under the skin, which later turned malignant.

At about the same time, researchers at University of California at Davis confirmed that feline leukemia vaccines were also leading to sarcomas, even more than the rabies vaccine.

Further investigations led to alarming statistics: vaccine-induced sarcomas were estimated to be one cat in 1,000, or up to 22,000 new cases of sarcoma per year.

It wasn't long before veterinary professionals began to suspect vaccination as a risk factor in other serious autoimmune diseases. Vaccines were causing the animals' immune system to turn against their own tissues, resulting in potentially fatal diseases such as autoimmune hemolytic anemia in dogs (AIHA).

Delayed vaccine reactions were also the cause of thyroid disease, As in humans, one of the reasons why dogs and cats need vacallergies, arthritis, tumors and seizures in both cats and dogs.

These findings led to a 1995 article in the Journal of the American Veterinary Medical Association that concluded:

"There is little scientific documentation that backs up label claims for annual administration of most vaccines."

And then there's the issue of adjuvants.

Thimerosal, mercury, and aluminum-based adjuvants are still being allowed in veterinary vaccines. So, your pet is being exposed to potential antigens that could abnormally stimulate his immune system, but last a lifetime and cause chronic disease. The less of this, the better.

Is Non-Vaccination a Greater Danger?

Giving your dog or cat a vaccine when it is already immune does not give any additional immunity, and it creates an unnecessary risk to your animal.

Evidence suggests that, like humans, dogs and cats could be vaccinated with certain vaccines early in life and be protected for a lifetime. With the exception of rabies, the core vaccines probably last at least seven years and should not be given more often than every three years.

In one study, the antibody levels of more than 1,400 healthy dogs of all ages were measured for parvo and distemper. Nearly all the dogs were immune (95-98 percent), suggesting that annual revaccination may not be necessary.

Many of the non-core vaccines are bactrins, vaccines created to treat non-viral infections (Lyme disease and Chlamydia, for example) and may have a shorter duration; about one year. But not all animals are at risk of exposure, and the vaccines have proven to be significantly more reactive to the immune system, so assessing risk versus benefit is very important before considering these very reactive vaccines. .

Researchers say there has been no increase in disease rates among dogs who have gone to vaccines every three years. And there is ample evidence that the dangers of repeated vaccinations are real.

A study published by Purdue in 2005 found correlations between vaccine reactions in dogs and variables such as age, size, and number of vaccines given. The study found:

- Smaller dogs are more prone to vaccine reactions than larger dogs
- Risk of reactions increased by 27 percent for each additional vaccine given per office visit in dogs under 22 pounds, and by 12 percent in dogs over 22 pounds
- Risk increased for dogs up to 2 years old, then declined with age
- Risk increased for pregnant dogs and dogs in heat
- More reactions were found in small dogs given Leptospirosis vaccine

cine protection at all is that they aren't eating an ideal diet. The better your pet's nutrition is, the healthier his immune system will be, and better able to fend off pathogens.

My Vaccine Recommendations

Wellness visits are important for other reasons than vaccines, such as checking for heartworm and tumors and assessing general health status. I do recommend continuing these checkups every six months, *although I do not recommend annual vaccines*.

Rabies vaccines are required by law. There are approved 1-year and 3-year rabies vaccines. *They are the same product*. Please ask for the 3-year vaccine, if you opt to vaccinate your pet against rabies. I also recommend you consider finding a holistic vet that will provide you with the homeopathic rabies vaccine detox, called Lyssin.

Ask for a Vaccine Titer Test: this is how you can determine if your pet has adequate immunological protection from previously administered vaccines (puppy or kitten shots). Antibody levels can be measured from a blood draw, in place of revaccination. The type of titer that best assesses immune system's response to vaccinesis called IFA, or indirect immunofluorescent antibody.

Please discuss with your vet the risks versus benefits of the diseases you are considering vaccinating for, before you automatically assume additional vaccines are necessary.


Indoor housecats should not be vaccinated annually, especially if they never go outside or have access to other cats (potentially exposing them to infectious disease). I believe overvaccination is one of the main reasons the general health of our feline patients is deteriorating.

Do not vaccinate your dog or cat if it has had a serious lifethreatening vaccine reaction.

Do not patronize any boarding facility, groomer, training facility or veterinarian that requires you to vaccinate your pet more than necessary.

The decision by some vets to come forward with the truth about pet vaccines is a positive step toward changing our animal health care system. Veterinary vaccines are one more unfortunate example of the corporate greed that permeates the pharmaceutical industry.

My relatives and I have been teaching our mom, Betty, about training Bulldogs for a lot of years. She's learned about raising puppies and training for competition in obedience, rally, agility and carting. Of course you know Bulldogs are very special dogs and that there is a knack to training them. We'd like to make this a monthly column in the Bulldogge and answer questions you send to us about training, living with your Bulldog, and even competing in rally and obedience or other fun events.

So, to get started, here is a "Tip of the month":

In any kind of training you MUST have your dog's attention. Attention is a two-way street; you must pay attention to your dog if you expect him to give you attention. Start with a GOOD treat, for example: hot dog slices, bits of cooked chicken or any other meat, liver dog treats.... Each bite can be the size of a pea. You don't have to use the whole slice (note from Prize, that isn't a bad idea though!). Take your bully into the kitchen or a place where he usually pays attention to you. Stand still and say his name quietly, then wait. The instant your dog looks at you smile, happily say "good boy" and give a bite of treat. If you are holding the treat in your hand, keep the hand near your face. You want your dog to look up at you, not at your

hands. You can place the treats on the counter within reach, too.

Repeat this several times. You want your dog to learn "all I have to do is look at this fool and she will give me treats." In a short time, your dog will be looking at you all the time. Anytime you see him watching, praise him, even if you are not training or don't have a food treat. When he reacts each time you say his name, go to places that are more distracting and repeat the exercise. You want your dog to think you are more interesting than anything else in the world.

Have FUN!! This is a game.

AKC Event Committee Bulletin

The AKC Event Operations department has announced the creation of an electronic newsletter entitled the *Event Committee Bulletin.*

The purpose of this newsletter is to provide increased assistance to

event committees and offer suggestions of how to creatively adapt to and embrace the ever changing demographic of our fancy. Each Event Committee Bulletin will contain articles on various issues that may have an impact on the hosting of dog show events. The tools and guidance provided may potentially help you put on more efficient, enjoyable, and innovative events. It will also provide you with helpful contact information for multiple AKC departments, should you wish to offer additional suggestions or need further clarification. The definitive goal is to help your club better serve the fancy, while keeping you up to date on happenings at the AKC relevant to events.

Shedding Light on the AKC Mixed Breed Program As many of you have heard by now, the AKC Board of



Directors approved the implementation of a Mixed Breed Program. The establishment of this new and inclusive initiative will help to promote the aims and ideals of responsible dog ownership to

those dog lovers who may have had no previous association with AKC. It will allow those who have a mixed breed to experience a new or increased partnership with AKC while furthering the well-being of our furry friends. This exciting opportunity will not only benefit AKC, but it will also help contribute to the rehabilitation of event entries. However, event committees must prepare to lay out some additional effort to make sure that the new Mixed Breed Program is well integrated and reaches its full potential.

As of October 1, 2009, mixed breed dog owners will begin enrolling their pets to receive an AKC ID number. Shortly thereafter, on April 1, 2010, newly listed dogs will be eligible to compete in mixed breed classes at stand-alone AKC Agility, Obedience, and Rally events. However, these



classes may not be offered at All Breed shows, Group shows, or independent specialties, regardless of whether Agility, Obedience, or Rally events are being held. Additionally, for the sake of governance, mixed breed dogs will be required to compete in

separate class divisions from purebred dogs. It is important to note that all of the titles that mixed breed dogs attain will have a special designation; an "M" will be added to the end of titles earned to designate that the dog is a mixed breed (i.e. NAM, MACH-M, OTCH-M). With regard to National Championships or Invitational events, dogs competing in mixed breed classes will NOT be eligible to participate.

In a letter announcing the program to the Delegates, AKC President Dennis Sprung and Chairman of the Board Ronald Menaker emphasized that "the creation of this program ushers in new opportunities for our constituencies, our clubs and our organization to grow and flourish in many ways." When mixed breed dog owners list their pet with AKC, they will immediately become part of the 125 year tradition of advocating for the best interest of dogs. Embracing this new program means furthering the mission and vision of the AKC and will positively contribute to future event participation. As pointed out in the Mixed Breed Program frequently asked questions, "we can best promote our shared values and bring people into the world of AKC events by reaching out to new dog owners no matter their origin." The potential is limitless for mixed breed dog owners who have no prior experience with the AKC. Clubs, of course, are encouraged to take part in the hosting of a mixed breed event and to help publicize this new program.

SB250 as Amended August 31, 2009 (posted Sept. 1, saveourdogs.net)

SB250 Update

The latest amendments are up.

The most significant thing about these amendments is that they require the bill to go back to the Senate. Prior to these amendments, the bill only needed to pass in the Assembly before going to the Governor's desk.

There are some minor changes, but nothing that makes the bill any better. Save Our Dogs opposes this latest version.

What is important however, is that this version contains language that purports to exempt a few classes of working dogs. As we have written before, exemptions for working dogs do not protect those dogs. This is no exception.

(*l*) Nothing in this section shall apply to any of the following,

provided the subject dog is licensed pursuant to Section 30801,

Section 121690 of the Health and Safety Code, or as required by the local licensing agency: (2) Any owner or breeder of a dog used in the

business of cultivating agricultural products.

This "exemption" was added specifically to cover insect detection dogs used to detect insect pests in vineyards. Let us consider the hypothetical case of an insect detection dog, Rita.

This is a new-ish use for dogs, so although Rita is the most experienced dog in the State, she is just two years old. She is intact and her owner/handler plans on breeding her someday, but this has nothing to do with Rita's ability to do her job. This exemption covers Rita. But what about Rita's parents?

Neither of Rita's parents were insect detection dogs. Nor were they police dogs, service dogs, hunting dogs or any of the other "exempt" categories. Nor are the owners of Rita's parents involved in any of the special businesses that would qualify them for exemptions. So Rita's parents would suffer the full weight of the law. And if either of them had been spayed/neutered then Rita would never have been born. The exemption does not protect Rita.

Let us suppose, though that Rita's father, Rex, was owned by a police dog trainer. Under another section, Rex would be exempt when he was bred to Rita's mother. But Rex was purchased at 18 months of age from a private individual. Rex's first owner bought him as a pet, but then discovered that Rex was too much dog and found a place where Rex could do what he was born to do. But for the first 18 months of his life Rex was not owned by a police dog trainer and so was not exempt. If Rex's first owner had neutered him at 6 months old as the law requires, then



there would be no Rita and insects would overrun the California vineyards.

The problem with the specific exemption language in this

version of SB250, and with all attempts to exempt working dogs, is that there is no bright line between the parents of working dogs and pets. Further this law requires that this non-existent bright line be drawn when the dog is 6 months old. It is simply impossible to protect the breeding stock for future working dogs without exempting all dogs. It is only when the dogs are five and eight years old and their offspring are working that you can say, "this dog is breeding stock for working dogs", These laws require that the dog be identified at six months and that is impossible.

The only thing that this language does is perhaps mislead

some people into believing that police dogs, service dogs, herding dogs and others are protected. We need to do everything in our power to explain that these so-called exemptions do nothing. Please contact your representative and explain this to them. All California working dogs need your help.

SB250 Update (posted 29 August, Saveourdogs.net)

The votes were posted for yesterday's Assembly Appropriations Committee hearing of SB 250. Contrary to what the Chair indicated, <u>the final tally</u> was not a simple party line vote.

Assemblymember Charles Calderon (D-Montebello) voted NO.

Assemblymembers Isadore Hall (D-Compton) and Mike Davis (D-Los Angeles) are listed as abstained, not voting, or absent.

Had nothing else changed, SB 250 would have died yesterday because it would have lacked the necessary number of YES votes. But a last minute addition of Assemblymember Jerry Hill (D-San Mateo) to the Appropriations Committee gave SB 250 the final YES vote it needed to pass.

The Chair indicated that amendments would be made to SB 250 to exempt rescue dogs (presumably means SAR dogs), herding dogs, guide dogs, and hunting dogs.

SB 250 now goes to the full Assembly for a vote. Since it is being amended, if SB 250 passes the Assembly it will have to go back to the Senate for a concurrence vote. Both of these steps must be complete by September 11. Since we have two more opportunities to defeat SB 250, each of

Rules for Nomination of Club Officers, Bulldog Club of Northern California, Inc. Constitution and By-Laws (1992)

The nominations may be made by any member in attendance provided that the person so nominated does not decline when his/her name is proposed, and provided



further that, if the proposed candidate is not in attendance

at this meeting, his/her proposer shall present to the Recording Secretary a written statement from the proposed candidate signifying his/her willingness to be a candidate for that office.

No person may be a candidate for more than one position, nor stand for another office while fulfilling a term of office which does not expire at the end of the current Club year except by so doing, automatically resign at the end of said year of that Officer or Director position. Nominations would then be in order to fill the balance of that term.

Nominations cannot be made at the annual meeting or in any manner other than as provided in this Section. (BCNC Constitution and By-Laws —1992)

us needs to contact our own senator and assemblymember and ask them to vote NO.

From PetPAC (Sept. 8, 2009):

California State Senator Dean Florez, the author of Senate Bill 250 which mandates mandatory pet sterilization, wants to forever change pet ownership in California and perhaps the United States. Florez who is running for Lieutenant Governor in 2010 is not a friend-- in fact his SB 250 is downright mean to pets and their owners....

According to the California Department of Finance, SB 250 will result in an increase in shelter intakes and more dogs and cats being killed. It also states: "Mandatory spay and neuter provisions have failed throughout California...there is no conclusive evidence that these

efforts would result in additional revenue to the state or counteract animal overpopulation."

But the California Department of Finance goes even further stating, "This bill would add the term "custodian" to the Food and Agricultural Code, which would have farreaching implications. **Specifically, the term "custodian" may reduce the legal status and value of dogs and cats and restrict the rights of owners, veterinarians, and government agencies to protect and care for animals.** The term "custodian" would also discourage volunteers from participating in trap/neuter/ release programs for feral cats, also resulting in increased rates of impounded cats."


